# **Bye - Laws of Telangana Tahsildars Association, (TGTA) (Regd. No. 815/2010)**

## **CHAPTER - I**

### **ARTICLE - 1: HEAD QUARTERS OF THE STATE ASSOCIATION**

1. The Central Office of the Association shall be at the State Head Quarters of Telangana.

### **ARTICLE - 2: RESERVATIONS IN OFFICE BEARER POST AND OTHER CONDITIONS FOR CONTEST**

- (a) The Treasurer shall be elected from the members of GHMC Limits at Hyderabad. The President, Two Associate Presidents, General Secretary, one Secretary and one Joint Secretary shall be elected from the members working in the entire state. The Vice-President shall be elected from the Zones at the rate of Three for each Zone by rotation. There shall be 3 posts of Secretaries and three posts of Joint Secretaries for each Zone by rotation of Districts excluding the posts of Two Vice Presidents and Two Joint Secretaries earmarked for the GHMC Limits at Hyderabad and The Law secretaries earmarked for the each Zone one.

- (i) Any person on his election to the post of President, General Secretary has to put up his residence at Hyderabad and also to work at Hyderabad on deputation basis till the post ceases.
  - (ii) One post of Secretary and Two posts of Cultural Secretaries shall be reserved for women. The Secretary General post shall be reserved for the ZONE V.
  - (b) The President, Secretary and Treasurer of the District Branches, shall be elected from the members working anywhere in the District along with other office bearers and Executive Members.

### **ARTICLE - 3 : AIMS AND OBJECTS**

#### **The Aims and Objects of the Association are :-**

- (a) To work for the welfare of Revenue Employees.
- (b) Protect the Revenue Employees Service Rules.
- (c) To provide efficient service to the people by improved methods of work, specialization of vocational and professional techniques.
- (d) To secure improved wages, and better working conditions to all Revenue Employees.
- (e) To promote consciousness of rights and duties among Revenue employees.
- (f) To secure full recognition and enjoyment of the rights and liberties to which Revenue employees are justly entitled.
- (g) To advance the Economic, Social and Cultural well-being of Members.
- (h) To take up all such other measures as are incidental and conducive to the attainment of the above objects.
